All art work has to be juried before hanging. You are responsible for hanging all your own work and providing labels. You may change out your work every month or every other month. The wall space is rotated every month. Artwork should be framed appropriately, if done on paper, and should only be framed with plexiglass, unless a charcoal or pastel work. The gallery does not accept any artwork which is offensive in nature (nude artwork cannot be hung). Understand that when hanging in the Gallery, you agree to donate back twenty percent (20%) of all sales made through SLAC&G. For further details about hanging in the Gallery, please review the Gallery Member handbook, provided upon request.

Gallery space is a 4'x9' space and the rent is \$40 a month. Rent is due on the 1st of each month. If payment is not received by the 5th, your piece will come down and held for 30 days for you to pick up. After the 30 days it will be disposed of at the discretion of SLAC&G.

This agreement will continue on a month to month basis for as long as you are making your payments.

Note: Each member has the option to hang his/her art each month but is not a requirement.
